 not issue a company IRD number without a link to all individual shareholders.
- 2. A copy of the Directors and Shareholders current passport or driver's licence is required.
- 3. It is prudent to seek Trade mark registration of your company name.
- 4. A company is required to file an "Annual Return" with the companies office on annual bases. The cost of this exercise is \$140.00 plus GST. Company Resolutions must be signed by the Shareholders to that effect and filed in the company minute book.
- 5. The company formation process can be completed within 24 hours of receipt of all relevant information.
- 6. The cost of company formation is as follows:

Identity Verification (all shareholders and directors required)	\$ 20.00 per verification
Company formation charges (payable to companies office)	\$ 120.00
Company with up to 5 individual shareholders	\$ 580.00
LTC registration	\$ 150.00
Additional with Trust shareholders (new trust to be formed)	\$1,000.00
Additional with Trust shareholders (use of existing trust)	\$ 200.00
Overseas companies (additional cost)	\$ 200.00
